Required COVID-19 Waiver

WAIVER (The “Agreement”)

By signing below, you are agreeing to follow our social distancing and safety protocols.

Although strict measures are being taken by Limelite Dance Studio to prevent the spread of COVID-19 (such as social distancing, staggered classes, and deep sanitization, etc.), the undersigned acknowledges that attending classes at Limelite Dance Studio could result in COVID-19 infection. Accordingly, in addition to all waivers and limits on liability already agreed to by the parties and because of the COVID-19 Pandemic, the undersigned, **HEREBY WAIVES AND RELEASES**, indemnifies, holds harmless and forever discharges Limelite Dance Studio and its members, agents, employees, officers, directors, contractors, affiliates, successors and assigns, of and from any and all claims, demands, debts, prosecutions, expenses, causes of action, lawsuits, damages and liabilities, of every kind and nature, whether known or unknown, in law or equity, that I ever had or may have, arising from or in any way related to participation in any of the events or activities conducted by, on the premises of, or for the benefit of Limelite Dance Studio provided that this waiver of liability does not apply to any acts of gross negligence, or intentional, willful or wanton misconduct, further, it is acknowledged that operation during the pandemic does not fall into these categories.

I also understand that the activities that I will participate in may be considered inherently dangerous and may cause serious or grievous injuries, including bodily injury, COVID-19 infection, loss of/damage to personal property and/or death. On behalf of myself, my heirs, assigns and next of kin, I waive all related claims for damages, injuries and death sustained to me or my property that I may have Limelite Dance Studio.

By this Waiver, I assume any risk, and take full responsibility and waive any claims of personal injury, COVID-19 infection, death or damage to personal property associated with Limelite Dance Studio including but not limited to receiving training at the facility, using the facility and its equipment in any manner, form or fashion, and practicing and/or engaging in activities or other related activities on and off the premises.

I agree that myself/ child(children) do not currently, nor have had in the last two weeks a fever, cold, vomiting, diarrhea, cough, sore throat, chills, muscle pain, fatigue, shortness of breath and/or loss of taste or smell. To the best of my knowledge, I affirm that I, as well as those living in my household, have not been diagnosed with COVID-19 or knowingly been exposed to anyone diagnosed with COVID-19 within the last 14 days. If I, or anyone else, I have knowingly been exposed to is diagnosed with COVID-19, I will only return to Limelite Dance Studio after 14 days without symptoms and/or being cleared of COVID-19 by a doctor.

I have read, understand and fully agree to the terms of this Agreement. I understand and confirm that by signing the Agreement I have given up considerable future legal rights. I have signed this Agreement freely, voluntarily, under no duress or threat of duress, without inducement, promise or guarantee being communicated to me. My signature is proof of my intention to execute a complete and unconditional **WAIVER AND RELEASE** of all liability to the full extent of the law. I am 18 year of age or older and mentally competent to enter into this waiver.
